The General Membership Election will take place Thursday, June 12, 2025 between the hours of 8am and 5pm at the local union meeting hall located at 6809 SE Bellagio Ct Ankeny, IA. The election will take place via secret ballot. The ballots will be counted immediately following the closing of the polls and the results shall be announced after all the ballots are counted. Candidates elected to office will be sworn in at the next regular meeting, July 10, 2025.

Absentee Ballots are available to any member upon <u>written request</u> to the election judge. An email has been established for general questions related to the election process and/or for absentee ballot requests: <u>347electionjudge@gmail.com</u>. Such requests will be accepted up to 5 (five) days prior to the date of the election. Anyone receiving an absentee ballot will not be entitled to vote at the polls without first presenting the election judge with their unused ballot and the envelope used in the mailing. Absentee ballots received at the post office box after 5pm on June 12, 2025, will not be counted.

Please remember: Candidates shall be entitled to an observer at the polling place and during the counting of the ballots. Observers may not interfere with the orderly procedure of the election.

We have several candidates this year. In the event a run-off election is required, it will be held on July, 3, 2025. The same rules apply to the run-off election as to the regular election. The run-off election

(if required) will be held from 8am to 5pm at 6809 SE Bellagio Ct Ankeny, IA. Members who requested an absentee ballot for the regular election will automatically receive an absentee ballot for the run-off election.
