Put best, the transition in TPAs is slow coming and a learning process for all. As of now, the HRA website and HRA app are both live. Please keep in mind, when logging in, you will only be able to view as far back as July 1st, as that was the date we switched TPAs. Deposits into your HRA will show the date the deposit was sent from your contractor (with the exception of the month of July, as they had to play catch-up): 7/1 should be your balance transfer, 7/2 should be employer contributions for the hours worked in the month of May (after August's premium was paid), 7/16 should be employer contributions for the hours worked in the month of June (after September's premium was paid), 8/15 should be employer contributions for the hours worked in the month of July (after October's premium was paid). These are all deposits into your account. Please keep in mind, if you have used your HRA debit card at all since the transition or filled out an HRA reimbursement form, you will also have debits from your account. The HRA app (Solxsys HRA) and website can be found on the back page of every newsletter moving forward.
