~Business Manager's Report~

Sisters and Brothers,

There is a lot happening these days, although not unusual. This year the Local had a record number of delegates (7) attend the IBEW 40th Convention (originally postponed due to COVID). We hosted the IBEW 11th District Progress meeting here in Des Moines, which we have not done since 2008 and we also held Union elections all while in the middle of bargaining over contracts with EP2 and KCCI. The remainder of the year will determine the outcome of three additional Agreements; Firestone, Keystone and the Statewide VDV Agreement (VDV askings meeting; August 17). All business as usual. As I write, the Laborers LU 177 are in a dispute with three employers at the COSTCO project in Ankeny which displaced some of our members from the site for a few days. The dispute is likely to continue for awhile but a dual gate system has now been established. A dual gate system as recognized by the National Labor Relations Act gives the GC on a construction project the ability to create a second entrance into a site, the neutral entrance. The neutral entrance is to be used exclusively by all employers/employees/suppliers of the neutral parties while the primary gate is to be used exclusively by the employers/employees/suppliers that are in a dispute with the respective Union. Once this system is set up correctly and legally, all other craft Unions are generally required to notify their members to utilize the neutral entrance so as not to put the Local in potential litigation over issues such as a sympathy strike. It can seem a little confusing and every situation is unique so if you find yourself pulling up to a jobsite that has a picket on it, the best way to handle it is to turn around and call me at the Hall. Do not cross.

The annual Investment Energy Conference is set to begin at 5:00pm on Tuesday, August 23 here at the Union Hall. This event was established to provide additional retirement/investment education to plan participants and their spouses. During this particularly volatile time in the global economy, who couldn't use the additional insight? This year's impressive lineup of speakers will discuss your investment options along with todays financial climate and provide you with the insight to make prudent investment direction choices based on your retirement goals and expectations. After the education piece, the IEC will host a casino night at LU 347. September 24; Ft Dodge Wellness Event On the health front, it is important to know that our health plan will not cover an Injury or illness that arises out of the course of employment. This type of illness or injury is insured by your employer under Workers' Compensation and should always be reported as such. Our health plan is a self funded plan which means there is no "insurance company". Its simply our money in, our money out. Our premium is based on claims activity and industry trend. If someone incorrectly submits a claim related to an injury that could have been paid by Work Comp, it puts the burden of that expense directly onto our Sisters and Brothers, taking food off their tables. If you suffer an injury at work, be sure to report it to your employer immediately so it can follow the correct course in regard to coverage. There are ways we can try to reduce costs in order to keep our premiums down. We can save money by understanding the cost differences between same day utilization options. The average cost to the plan per visit for those services is illustrated below:

Average Cost to the Plan
Per Visit:
ER - \$1,226
Telehealth - \$59
Urgent Care - \$110
PPO Virtual Visits - \$96

As shown in the chart, the ER visit has the most immediate and substantial impact per visit. Of course, if there is an emergency, no other options are viable but in many cases, urgent care or telehealth may be just as effective at a significantly reduced cost to the plan and to the participant. Our telehealth benefit, Dr. On Demand, costs you zero out of pocket for that visit.

Our plan premiums are actually lower today than they were five years ago and that is a rare occurrence in the medical industry. Lets all work together to keep our premiums low and protect our plan benefits for the next generation of electrical worker.

The IBEW is committed to the Electric Vehicle Infrastructure Training Program (EVITP) and currently working to get as many Journeymen trained and certified as possible in order to secure the work that is being implemented by the Infrastructure Investment and Jobs Act. This training is a critical component designed to be sure only qualified, licensed Journeymen are eligible to perform the work. This will give us an advantage over our competitors, but only if we have the certifications to back up our experience. Political Corner

While we still have a few months until the midterm elections in November, I'd like to take some time to go over some changes to the voting rules in Iowa that were made last year. Many of these changes boil down to reducing the amount of time you have to cast your ballot, or otherwise making it more difficult to vote. Remember that polls now close at 8 PM on Election Day rather than 9 PM. You now have a smaller window to vote early in person with that period starting 20 days, rather than 29 days before Election Day. You also need to bring an ID to the polls, such as your driver's license, to be able to vote. The biggest changes were made to the mail-in ballot system.

If you plan to use a mail-in absentee ballot, you need to be aware of the timeline to make sure that your vote is counted. The new deadline for receiving ballots at your county auditor's office is 8 PM on election day, rather than the following Monday as it was previously. You will not receive an Absentee Ballot Request form automatically, so you must either be request one or print one out yourself. The people that are allowed to return someone else's absentee ballot have also changed, and it is now limited to a member of your household, an immediate family member, or a caregiver.

This year we have a chance to elect new representatives to several offices; including a U.S. Senator, four U.S. House seats, and the Governor, among others. These races will not be easy and we will need to put the work in if we want to win. Contact Randy Tucker at the hall to volunteer.

State Licensing Continuing Education Courses:

The Des Moines Electrical Apprenticeship will post new classes on our website www.dmelejatc.org and our Facebook page. Please use the on-line registration to sign-up for the classes. Make sure that you complete the registration process by putting the class in your "cart" and then checking out. If you have completed the process and checked out you will receive a confirmation email from the system. If you do not receive an email the sign-up process was not completed. If you do not see any classes posted it is for one of two reasons: no classes are scheduled or the classes are full. Keep in mind that you will need to have 18 hours of CEUs (6 must be code) by December 31, 2022 in order to renew your license.
