Brothers and Sisters,

The 2022 primaries are almost here! Both the Democratic and Republican primaries will be held Tuesday, June 7th this year and the polls will be open from 7AM to 8PM. You can vote early in person at your local county auditor's office any time they are open, up until June 6th. If you requested a mail in ballot, it needs to be received by your auditor's office no later than the day of the election. If you have a mail in ballot that you don't think you can send in time, you can instead hand deliver it to your auditor's office by the end of election day or surrender it at your polling place on election day to vote a regular ballot. For your reference, I have included a list of all of the AFL-CIO endorsed candidates that will have a primary.

The 2022 legislative session is still dragging on as I write this, but a couple of things have changed since last month. First, a version of the bad unemployment bill we've been watching made it through the legislature. This bill cuts unemployment benefits by 10 weeks, from 26 to 16. Fortunately, a provision to add a one week waiting period on top of the cuts was dropped. The legislature also passed a childcare bill that lowers the age of unsupervised childcare workers to 16 and allows childcare facilities to have more children per caretaker. These controversial changes seem unlikely to improve the quality or safety of Iowa's daycare facilities. Lastly, there is the private school voucher bill that Gov. Reynolds has been pushing. If passed, the voucher bill would transfer money from already underfunded public schools to private schools that serve far fewer Iowa students.
