The special election for Warren County Auditor is now over, and I wanted to take a moment to thank all of you who went out and voted. Fortunately, our endorsed candidate Kim Sheets won by nearly a 2-1 margin. This goes to show the importance of voting consistently, including in special elections. Keep this in mind going into our City-School Election in November. With that said, there are some important dates leading up to the November 7th election.

If you are not registered to vote, you can pre-register online or by mail until October 23rd. You can also register on election day with a valid photo ID. You will need proof of residence if your ID does not show your current address. Early in person voting is available Wednesday October 18th – Monday November 1st. Mail-in ballot request forms must be received at your county auditors office by Monday October 23rd. Mail in ballots must be received at the auditor's office by 8pm on Election Day. Election Day will be Tuesday November 7th. The polls will be open 7am – 8pm. City run-off elections will be held December 5th, in cities with run-off provisions. If you don't know your polling place, you can find it online at the Iowa Secretary of State's website, sos.iowa.gov.

The annual Investment Energy Conference is set to begin at 5pm on Thursday, October 19th here at the Union Hall. This event was established to provide valuable investment guidance to plan participants, and help with early stage retirement planning. This year's speakers will discuss your options and provide you with the insight to direct your investments based on your goals and expectations upon retirement. 
