Apprenticeship News

JW class numbers:

2017- 29 classes offered, 17 cancelled.

2018- 46 classes offered, 20 cancelled.

2019- 41 classes offered so far, 1 cancelled.

52 six hour courses were offered.

56 three hour courses were offered.

8 twelve hour courses were offered.

24% of available seats in the classes held went unfilled. 33% of offered classes had to be cancelled.

Make sure that you complete the registration process by putting the class in your "cart" and then checking out. If you have completed the process and checked out you will receive a confirmation email from the system. Keep in mind that you will need to have 18 hours of CEUs by December 31, 2019 in order to renew your license.
